## Introduction

- Gold mining contributes substantially to Ghana's economic development (revenue, taxes, etc.)
- Socioeconomic, health and environmental impacts outweigh the benefits
- In Ghana, mining laws lack provisions for effective land reclamation and restoration
- Extent mining policies promote sustainable land reclamation and innovative postmining restoration strategies?
- Challenges and bottlenecks in the mining value chain?

## **Findings**

- · Generic policies lacking details (specificity)
- · Limited enforcement of mining regulation
- · Logistic challenges
- · Neglected actors (geologists)
- Little funds for implementing and monitoring activities
- · Lack of technical know-how and expertise

- Quantitative household survey (N=100)




Fig 1 Conducting Net-Mapping




Fig 3 Reclaimed land area

Fig 2 From mining to reclamation – land use framework




Fig 4 Incentives for land reclamation
